## 3. HAZARDS IDENTIFICATION

**Main hazards:** Irritating to eyes and skin.

## 4. FIRST AID MEASURES (SYMPTOMS)

**Skin contact:** There may be mild irritation at the site of contact.

**5. FIRE-FIGHTING MEASURES**

**Extinguishing media:** Suitable extinguishing media for the surrounding fire should be used.

**Protection of fire-fighters:** Wear self-contained breathing apparatus.

**6. ACCIDENTAL RELEASE MEASURES**
